FEBRUARY 2017 COMMENTARY

The Fiera Capital Diversified Alternatives Fund (the “Fund”) returned 0.63% net of all fees and expenses for the month of February. All of the Fund’s sub-advisors were profitable during the month. Equity market neutral trading and long positions in global equity indices contributed positively to performance, while currency trading detracted.

Since inception in July 2014, the Fund had a net return of 0.83%. During this time, it outperformed the HFRX Global Hedge Fund Index (-1.87%) by 2.70% and underperformed the MSCI World Index (9.99%) by 9.16%.

The MSCI World TR Index is a free float-adjusted market capitalization weighted index that is designed to measure the equity market performance of developed markets. It is comprised of all eligible hedge fund strategies; including but not limited to convertible arbitrage, distressed securities, equity hedge, equity market neutral, event driven, macro, merger arbitrage, and relative value arbitrage.
