#### **JULY 2017 COMMENTARY**

The Fiera Capital Diversified Alternatives Fund (the "Fund") returned 0.21% net of all fees and expenses for the month of July. Two of the Fund's four sub-advisors were profitable during the month. Positive performance was driven by long investments in global equity indices and profitable trading in currencies and commodities. Partially offsetting these gains were negative results from equity market neutral investment strategies.

Since inception in July 2014, the Fund had a cumulative net return of 2.31%. During this time, it outperformed the HFRX Global Hedge Fund Index (-0.05%) by 2.36% and underperformed the MSCI World Index (18.40%) by 16.09%.
